The candidate challenging the provisional answer Key(s) shall have to pay a non-refundable fee of  $\gtrless$  100/- (Rupees One Hundred only) per question subject to maximum of  $\gtrless$ 500/- ( $\gtrless$  Five Hundred only) in online mode only for which the link will appear before final submission of objection(s). No other mode of filing objections and depositing fee shall be entertained. Objection without depositing the requisite fee shall not be considered/ entertained.

Further in support of objection, candidate should upload authentic document/ reference in pdf format in support of their claim. No claim without any supporting document shall be considered despite of having paid requisite fee.
