No other mode of filing objections and depositing fee shall be entertained. Objection without depositing the requisite fee shall not be considered/ entertained.

Further in support of objection, candidate should upload authentic document/ reference in pdf format in support of their claim. No claim without any supporting document shall be considered despite of having paid requisite fee.
