7. No further opportunity will be provided to the candidates to attend the Evaluation after the scheduled date and they will be treated **absent** and their candidature will also be rejected. No request for any change in date allotted to candidates for Evaluation will ordinarily be entertained.

The e-call letter(s) for evaluation to all shortlisted candidates for the above mentioned posts have been uploaded on their respective User IDs alongwith Instructions to the candidates for evaluation. The candidates are advised to download the e-call letters and bring the same on the day of evaluation. No Call letters will be sent separately to individual candidate by any other mode.
