**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Himachal Pradesh is pleased to make the following rules regulating the reservation of vacancies in the Himachal Pradesh Administrative Service for Demobilized Emergency Commissioned Officers, Short Service Regular Commissioned Officers, Junior Commissioned Officers, Non-Commissioned Officers and other ranks of the Armed Forces of the Indian Union (hereinafter called the Released Indian Armed Forces Personnel) and the recruitment of such personnel on such vacancies, namely:-

| Reservation<br>of vacancies                     | 2. | (1) Twenty percent of the vacancies in the Himachal Pradesh Administrative Service to be filled in by direct recruitment shall be reserved for being filled in from amongst the Released Indian Armed Forces Personnel who joined military service or were commissioned on or after the first day of November, 1962 and are released at any time thereafter:   |

Provided that the Released Indian Armed

Forces personnel shall not be required to appear in optional subjects of the competitive examination.

- (2) On receipt of the result of the competitive examination from the Himachal Pradesh Public Service Commission, one vacancy in every block of five vacancies shall be earmarked for the Released Indian Armed Forces Personnel.
- (3) Where in any year any vacancies reserved for the Released Indian Armed Forces Personnel remain unfilled for want of suitable Released Indian Armed Forces Personnel, such vacancies may be filled up temporarily from any other source in accordance with the Himachal Pradesh Administrative Service Rules, 1973. The number of such vacancies shall be carried forward to the next succeeding years;

Provided that no such vacancy shall be carried forward for a continuous period of more than four year;

Provided further that the total number of vacancies reserved for the Released Indian Armed Forces Personnel and the Scheduled Castes, Scheduled Tribes and Backward Classes, in the Himachal Pradesh Administrative Service, shall not exceed, in any year, forty five(45%) percent of the total number of vacancies to be filled in by direct recruitment in the service in that year.

- Qualifications, age Limit etc. of Released Armed Forces Personnel.
3. No Released Indian Armed Forces Personnel shall be eligible to appear in the competitive examination prescribed for recruitment to the Himachal Pradesh Administrative Service unless;
    - (a) he possesses the minimum academic qualification prescribed in the Himachal Pradesh Administrative Service, Rules, 1973;
    - (b) his age at the time of joining military service, or training prior to the Commission, as the case may be, does not exceed the upper age limit prescribed in the Himachal Pradesh Administrative Service Rules, 1973;

Provided that no such candidate shall be permitted to compete more than three times at the examination; and

- (c) after released from the Armed Forces of the Indian Union, he is found to be medically fit in accordance with the provisions of the Himachal Pradesh Administrative Service Rules, 1973.

Fixation of Pay, seniority and retirement benefits.

- 4. (1) The period of military service rendered after attaining the minimum age prescribed for appointment to the Himachal Pradesh Administrative Service by the candidates appointed against reserved vacancies under rule-2, shall count towards fixation of pay and seniority in the said service subject to the condition that:-

- (a) The date of appointment in the Himachal Pradesh Administrative Service in respect of such candidates as are appointed against the reserved vacancies under rule-2 shall be determined on the assumption that they joined the service under the State Government at the first opportunity they had after joining military service or training prior to the Commission;
  - (b) The inter-se-seniority of the military personnel determined by the Himachal Pradesh Public Service Commission shall not be disturbed; and
  - (c) A military personnel appointed as a result of an earlier selection shall be senior to a military personnel appointed by direct recruitment in the year to which the former candidates are allotted.
- (2) The period of military service rendered after attaining the minimum age mentioned in Sub-rule (1) shall also count towards pension, subject to the following conditions:-
    - (a) The persons concerned should not have earned pension under the rules applicable to such service except disability pensions; and
    - (b) Any bonus or gratuity received from the military authorities in respect of military service shall have

to be refunded to the State Government.

Over riding 5. The provisions of these rules shall have effect effect of these notwithstanding anything to the contrary contained in any rules. other rules.

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article-309 of the Constitution of India and all other powers enabling him in this behalf, the Governor, Himachal Pradesh hereby makes the following rules further to amend the Demobilized Indian Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh Administrative Service) Rules, 1974, namely:-

1. These rules may be called the Demobilized Indian Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh Administrative Service) (Second Amendment) Rules, 1978.
2. These rules shall come into force with effect from the date of issue of this notification.
3. Sub-rules(1) and (2) of Rule-2 of the Demobilized Indian Armed Forces Personnel( Reservation of Vacancies in the Himachal Pradesh Administrative Service) Rules, 1974 shall be substituted as under:-

Rule-2 (I) Ten percent of the vacancies in the Himachal Pradesh Administrative Service to be filled in by direct recruitment shall be reserved for being filled in from amongst the Released Indian armed Forces Personnel who joined Military Service or were commissioned on or after the first day of November, 1962 and are released at any time thereafter;

(2) On receipt of the result of the Competitive Examination from the Himachal Pradesh Public Service Commission, one vacancy in every block of 10 vacancies shall be earmarked according to the roster prescribed by the Government, for the Released Indian Armed Forces Personnel.

Provided that this provision shall not be applicable to the posts of HPAS which have already been notified by the Commission.

In exercise of the powers conferred by the proviso to Article-309 of the Constitution of India and all other powers enabling him in this behalf, the Governor, Himachal Pradesh makes the following rules further to amend the Demobilized Indian Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh Administrative Service) Rules, 1974 namely:

Short title and commencement.

1. 1) These rules may be called the Demobilized Indian Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh Administrative Service (First Amendment) Rules, 1979.
- 2) They shall come into force from the date of issue of this notification.

Provided that nothing in these rules shall be applicable to the Vacancies already notified by the H.P. Public Service Commission during the year 1978.

Reservation of Vacancies

2. 1) The following note shall be added below sub-rule-I of Rule-2 of the Demobilized Indian Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh Administrative Service) Rules, 1974 namely;

Note:- For the purpose of this rule an ex-serviceman or a released army personnel shall cease to be so as soon as he joins the first civil employment under any State/Central Government;

- 2) Sub-Rule-I of Rule-4 of the Demobilized Indian Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh Administrative Service) Rules, 1974 shall be read as under:

Rule-4(1): Only the period of approved military service

rendered after attaining the minimum age prescribed for appointment to the service concerned by the candidates appointed against reserved vacancies under the rules shall count towards fixation of pay and seniority in the said service subject to the condition that:-

- (a) the inter-se-seniority of the military personnel determined by the Himachal Pradesh Public Service Commission shall not be disturbed; and
- (b) a military personnel appointed as a result of an earlier selection shall be senior to a military personnel appointed by direct recruitment in the year to which the former candidates are allotted.

Amendment in Rule 4 3. In rule 4 of the said Rules:-

Amendment in Rule-4 For the existing clause (c) of rule(1) of Rule 4 of the Demobilised Indian Armed Forces Personnel (Reservation of Vacancies in H.P. Administrative Service) Rules, 1974. The following clause (c) of sub-rule (1) of rule 4 shall be substituted, namely:-

“(c) a military personnel already appointed in civil employment against a reserved post under any State /Central Government, on his subsequent appointment to the Himachal Pradesh Administrative Service on the basis of competitive examination shall not be eligible for benefit of fixation of pay and seniority in the service (Himachal Pradesh Administrative Service) under sub-rule (1) of Rule “4”.

November, 1962 and are released at any time thereafter”.
