- 5. Category Certificate of SC, ST, OBC on parental basis, WFF, valid BPL and EWS Certificate along with Non SC/ST/OBC certificate wherever applicable. All these certificates should be valid on the closing date of Online Recruitment Application as well as on the day of document verification and should have been issued by the competent authority as notified by the Govt. from time to time.
- 6. "No Objection Certificate" from your present employer in case working on regular basis in Government/Semi Government Organization. Without NOC you will not be allowed to appear before the Document Verification committee and no further time will be allowed to produce NOC
- 7. Latest Character certificate from a responsible Officer (Gazetted Officer of Government/Semi Government Organization).
- 8. Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission's advertised vide Advertisement No. 27/11-2023 dated 21.11.2023
- 9. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 18-12-2023. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date).

- 10. Your admission to the Document Verification is purely provisional subject to the verification of your eligibility as per rules/instructions.
- 11. Onus or proving that you are eligible for the post is on you only.
