

HIMACHAL PRADESH PUBLIC SERVICE COMMISSION

(Instructions to Candidates for Personality Test for the posts of Assistant Research Officer, Class-II, (Non-Gazetted) (on contract basis) in the Department of Planning, H.P.

1. With reference to your application for the post of Assistant Research Officer, Class-II, (Non-Gazetted) (on contract basis) in the Department of Planning, H.P. **advertised vide Advertisement No.30/11-2023, dated 29-11-2023** and after security of documents, you have been provisionally admitted to the said post and now the Personality Test for this post will be held on **22-11-2024** in the office of the Himachal Pradesh Public Service Commission, Nigam Vihar Shimla-171002.
2. That you should ensure your presence in the H.P. Public Service Commission on the day of Personality Test (date indicated in e-admit card) **at 08:00 A.M.** i.e. on the day of Personality Test for verification of documents before appearing in the Personality Test Board.
3. The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
4. Please bring original Degree and Result-cum- Detailed Marks Certificates/ Sheet along with attested copies of the following documents with you:-
 - (i) Matriculation certificate showing your date of birth.

Essential Qualification: Certificates as per Advertisement

Master's Degree in Economics with Statistics or Master's Degree in Mathematics or Master's Degree in Statistics from a recognized University.

Desirable Qualification

- (i) **Three years experience in the field of collection, compilation of Statistics data.**
 - (ii) **Preference will be given to those who have higher qualification and experience in the line.**
 - (iii) **Knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.**
5. Scheduled Caste / Scheduled Tribe or **latest (valid) Other Backward Class certificate / EWS certificate** on the prescribed form, if you belong to any of these categories otherwise your candidature will be cancelled. The S.C. / S.T / O.B.C. certificate should be based on **parentage basis**. The candidates belonging to Ex- servicemen category shall bring discharge certificate & other related document issued by the competent authority as a proof of being Ex-serviceman. **No further time will be allowed to produce these certificate(s).**
 6. **"No Objection Certificate"** from your present employer in case working on regular basis in Government /Semi Government Organization. **Without N.O.C.** you will not be allowed to appear before the Personality Test board and **no further time will be allowed to produce N.O.C.**
 7. A latest **Character certificate** from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and **other Character certificate** from Head of the Institution last attended.
 8. You should download **Attestation Form** through the link provided in the Personality Test Call Letter and bring it with you duly filled in all respect and also **bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation Form** on the day of Personality Test.
 9. Any other certificates of your academic qualifications etc. in support of your eligibility for the post as required as per Commission's **Advertisement No. 30/11-2023, dated 29-11-2023.**

Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications (ORAs) i.e. **26-12-2023**. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).

10. Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.
11. Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.
12. If you fail to produce any of the certificates mentioned above, which is necessary to determine your eligibility and/or you are found ineligible vis-à-vis qualifications, you will not be allowed to appear before the Personality Test Board and no further time will be allowed to produce any document.
13. Besides, your eligibility will be subject to the conditions given in **No. 30/11-2023, dated 29-11-2023**. No T. A. / D.A. will be paid for appearing in this Personality Test However, 30% discount is allowed by the H.R.T.C. in ordinary buses only for attending the Personality Test as per communication received from HRTC and discount will be applicable for only three days i.e. one day before and after the Personality Test for to & fro journey.

(ii) NO ELECTRONIC GADGET / MOBILE PHONE / PENDRIVE / BLUETOOTH ANY OTHER COMMUNICATION / ELECTRONIC DEVICE IS ALLOWED DURING THE PERSONALITY TEST. THEREFORE, THE CANDIDATE SHOULD ENSURE THAT THEY ARE NOT IN POSSESSION OF ANY KIND OF SUCH DEVICES BEFORE THEY ENTER THE PREMISES.
