Q. No. 5. Discuss the provisions of the Rules regarding admissibility of Pension, Commutation of Pension and Retirement Gratuity of an employee who is due for retirement and against whom criminal as well as departmental proceedings for imposition of major penalty are pending.

- If the employee is acquitted by the Court on technical grounds within two months from the date on which he attained the age of superannuation.
- If the employee is found guilty and convicted by the Court.

Q. No.6. Mr. "A" an employee the Department of Agriculture, Himachal Pradesh was promoted to a higher post from Level-12 to Level-16 on 15.07.2024. He was drawing pay of Rs. 73200/- in the lower post since 01.09.2023.

Mr. "A" sought your advice whether he should get his pay fixed from the date of promotion or exercise option to get his pay fixed from the date of accrual of increment on the lower post.

You are required to fix his pay on promotion both ways, i.e. without exercising option as well as by exercising option to get pay fixed from the date of accrual of increment in the lower post and suggest which option will turn to be more beneficial based on information given hereunder:
