

HIMACHAL PRADESH PUBLIC SERVICE COMMISSION
Instructions to Candidates

- 1 That you have been provisionally admitted to the post of Medical Officer (Dental) Class-I (Gazetted) (on Contract basis) in the Department of Health and Family Welfare, H.P Advertised vide Advertisement No. 4/2019 Dated 09-03-2019 Item No. I (E) and now the Personality Test for the said post will be held on 28-09-2019 in the office of the Himachal Pradesh Public Service Commission, Nigam Vihar Shimla-171002.
- 2 That you should ensure your presence in the H.P. Public Service Commission on 28-09-2019 at 08:30AM for verification of documents before appearing in the Personality Test.
- 3 The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
- 4 Please bring original Degree and Result-cum- Detailed Marks Certificates/ Sheet along with attested copies of the following documents with you:-
 - Matriculation certificate or other equivalent certificate showing your date of birth.
 - The Essential Qualifications:
 - (i) A Bachelor of Dental Surgery Degree from the Institute recognized by the Dental Council of India.
 - (ii) Registered with the State Dental Council
5. “No Objection Certificate” from your present employer in case working on regular basis in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C
6. Latest Character certificate from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and **other Character certificate from Head of the Institution last attended.**
7. You should also bring with you enclosed Attestation Form duly filled in all respect and bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation Form.
8. Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission’s advertised vide Advertisement No.4/2019 dated 09-03-2019 (Item No. I(E)).
9. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 29-03-2019. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).
- 10 Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.
- 11 Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.

- 12 **Ward/Wives of Ex-Serviceman Certificate issued by a competent authority i.e. SDM/ Tehsildar along with a latest affidavit duly attested by the authority authorized under the Indian Oath Act to the effect that no person in the family has been rehabilitated through employment against the posts reserved for Ex-Servicemen under the Government of Himachal Pradesh. Besides, un-married daughter of Ward of Ex. Serviceman will have to submit an affidavit being spinster(un-married) issued by the authority authorized under the Indian Oath Act in support of their claim. Such Candidate(s) will not be allowed to appear in the Personality Test, if she fails to produce above mentioned affidavit on the day of personality test.**
- 13 If you fail to produce any of the certificates mentioned above, which is necessary to determine your eligibility and/or you are found ineligible vis-à-vis qualifications, you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce any document.
- 14 Besides, your eligibility will be subject to the conditions given in Advertisement No.4/2019 dated 29-03-2019 (Item No. I (E)).
- 15 No T. A. / D.A. will be paid for appearing in this Personality Test However, 30 % discount is allowed by the HRTC in ordinary buses only for attending the Personality Test as per communication received from HRTC and discount will be applicable for only three days i.e. one day before and after the Personality Test for to &fro journey.
